The Parish Subsidy Grant is awarded by your parish, not by the school. Please go to your Church office and ask for the subsidy paper work. Once you have completed the forms for subsidy, return them to your parish for your parish priest's signature. The parish will return the forms to Saint Mary Catholic School. The non-subsidized rate will apply until we receive the paperwork from your parish.

## 2018– 2019 SCHOOL YEAR FEES

### REGISTRATION (Currently Enrolled Students) Due at time of Registration for child/children to be considered registered.

Returning Student Fee (Non Refundable) ..... \$150 per Student / \$200 after 2/16/18  
\$450 Maximum per Family / \$600 after 2/16/2018 (3 or more children)

Priority Registration is February 5-16, 2018. In order for your child to be registered into class for 2018-2019, all 2017-2018 tuition must be current.

### REGISTRATION (New students)

Open Registration begins February 20, 2018. Space is based on availability.

All New Students (Non-Refundable) ..... \$200.00

### BUILDING FOR THE FUTURE FEE (For all families) Due by April 1, 2019..... \$600.00 per Family

One-time fee. If paid in a previous year, not assessed in 2018 – 2019 school year. Building for the Future Fee provides funding for campus improvements.

### GRADUATION FEE Due by April 1, 2019

Kindergarten ..... \$35.00  
Eighth Grade ..... \$60.00

### LUNCH PRICES (subject to change)

K4 - 8<sup>th</sup> Grade \$ 3.00  
Adults \$ 4.00 (subject to change)  
Milk \$ 0.50 (subject to change)  
Water/Juice/A la Carte \$ 1.50 (subject to change)

### WITHDRAWAL FEE

Withdrawal during School Year / Processing Fee ..... \$150.00 per child

### SPORTS

Sports fees vary with sport and are due at the beginning of each season (grades 5-8).

### F.A.C.T.S. (Fast Automatic Transfer System)

This service allows automatic direct deposit of tuition payments into the school account from your checking or savings. All families are required to be placed on F.A.C.T.S. Registration and Before/After Care Fees are not part of this program and are paid separately to the school. Bus Fees, Graduation Fees and Technology/Book Fees may be added to F.A.C.T.S.

ALL FAMILIES WILL BE ON A 10 MONTH PAYMENT PLAN (June 1-March 1)

You may choose to pay your Tuition in full before June 1<sup>st</sup>.

When school opens in August, three tuition payments must already be received.

ALL TUITION FOR THE 2018-2019 SCHOOL YEAR MUST BE PAID BY MARCH 1, 2019.
